### **EBC ANNUAL CONGRESS 2013**

How to combine internal market freedoms and an appropriate level playing field in the European construction sector?

# Brussels, 1<sup>st</sup> July 2013

Last week, representatives from European construction SMEs gathered in Brussels at the EBC Annual Congress to debate with MEP Jazłowiecka, social partners and representatives from the European Council and Commission on how to ensure free movement of workers and services, while avoiding the risk of social dumping.

"The European Internal Market offers opportunities of growth to construction SMEs. However, entrepreneurs need some minimum common rules at European level for posted workers to prevent undeclared work, bogus self-employment and social dumping," stated the European Builders Confederation's President José Antonio CALVO DELGADO opening the Congress.

Despite being a relatively small group (1.06 million working people), posted workers have qualitative and growing economic value, due to their capacity to supply the needs of special sectors and professional figures. Construction is one of the most affected sectors. Currently, lack of controls at national level and the insufficient exchange of information among Member States create a situation of unfair competition in the Internal Market for loyal SMEs which respect the social rights of workers.

"The new enforcement directive should not require SMEs to take up inspection responsibilities across national borders which belong to public authorities, we cannot be the police of posting", said Mr. Calvo Delgado. "Indeed, SMEs do not have these means of control, in particular in transnational situations, where geographical problems, translations and lack of information would make it extremely difficult".

EBC President Mr. Calvo Delgado concluded: "What we need are clear European criteria for posting, mandatory declaration prior to posting, open but transparent list of control measures, with notification by Member States and much better administrative cooperation between governments. In addition, we have always supported the application of joint and several liability, for which we propose an easy and light administrative tool, supported by MS cooperation at European level, for a reliable due diligence process".
